

Privacy policies

When you provide us with information through this website, www.diamondring.hk, we respect your privacy. It is important for you to understand what information we collect about you during your visit and what we do with that information. Your visit to this Site is subject to Privacy Policy and our terms and conditions.

1. Information Collection

We do not collect personally identifiable information about you, except when you provide it to us direct or through a third party. For example, if you decide to complete a user registration form, complete an online survey or make a purchase, you may be asked to provide certain information such as your contact information (name, email address, mailing address, and telephone number), birthday, gender, and product and/or cosmetic concerns, and the brands and products you use. To protect your personal information, users registering at this Site must also enter a user name and password.

Unless in exceptional cases covered by this policy statement, we will not sell or transfer personally identifiable information about you to a third party.

We may collect, store or accumulate certain non-personally identifiable information concerning your use of the Site, such as information regarding which of our pages are most popular. We may share or transfer non-personally identifiable information with or to our affiliates, licensees and partners.

We may disclose any information, including personally identifiable information, we deem necessary, in our sole discretion, to comply with any applicable law, regulation, legal process or governmental request.
